November 09, 2021

### **APPROVAL OF MINUTES:**

Mr. Denton motioned to approve the October 20, 2021 Regular Board Meeting minutes. Mr. Lee seconded. Vote: Denton – yes; Johnson – yes; Van Buren – yes; Lee – yes. **Motion carried.** 

### **CHIEF:**

- A. Todd Magers, Chief, informed the Board, the District sold the old tower to a fire department located in White Hall, AR for \$75,000.00.
- B. Chief Magers informed the Board, the burn building is coming along nicely. BC Bryan has been overseeing the completion of the project.

Stacie Baker jointed the meeting at 7:03 p.m.

#### **ASSISTANT CHIEF:**

- A. Jack Treinish, Assistant Chief, informed the Board the parking lot patchwork areas here at Station 401 have been completed.
- B. AC Treinish informed the Board, Station 402 concrete/demo work being done by Meeker Excavating LLC will begin on Thursday.
- C. AC Treinish distributed drawings for new Station 404 with the gable roof line as requested by the Board. Everyone agreed the gable roof line presented a much better appearance.

- A. Joseph Krouse, Assistant Chief informed the Board the October 2021 activity report is contained in their board packet. The District's run volume is going to be approximately 800 more runs than last year.
